



Application Guidelines

Aim

An important mission of the GTH is to foster research and collaborations in the field of thrombosis and haemostasis and support early career researcher. The GTH Early Career Research Grants have been initiated to support pre-clinical and clinical research projects, which have a high scientific and clinical impact and contribute to advances in the field of thrombosis and haemostasis.

Grant Amount Duration

The GTH awards up to three grants of up to €100,000.00 per year. The amount of the payment depends on a detailed cost calculation and cost statement. The duration of the research projects is limited to a maximum of 3 years.

Eligibility

The application process is open only to early stage researcher up to the age of 40 years, in which child caring periods will be respected. The key research activities should be carried out in the GTH countries (Germany, Austria, Switzerland) and embedded in a haemostaseological setting. Collaborative projects between research groups of the GTH countries are welcome. The membership in our professional society is not a prerequisite for application.

Application Documents

Applicants must submit these documents by **30 November 2021 at 23:59 CEST**:

- the completed application form (including detailed project proposal and financial plan)
- letter of motivation
- letter of recommendation or a documentation of a good research environment by the supervising institution

The application form as one single Word document or PDF has to be submitted together with the letters in email attachments to Kerstin Strohn at mail@gth-online.org with the title "GTH Early Career Research Grants" in the subject line. Applicants must adhere to the specific page limits indicated in the application document.

Evaluation Process

After initial formal assessment, complete applications will be reviewed by a Grant Review Committee. A prerequisite for nomination is at least two positive evaluations by external reviewers. The nominated applications are then submitted to the GTH Awarding Jury, which makes the final decision on the awarding of the prizes.

Reporting Requirements

Twelve month after the public announcement, the first progress report and a financial report must be sent to GTH. Either an interim or a final report has to be presented at the GTH annual meeting. The research grant recipient must agree to acknowledge the support of the GTH Early Career Research Grant in all abstracts, publications and oral presentations related to the funded project.

The announcement of the grant recipient will be made in **March 2022** during the GTH Annual Congress.
